Area Agencies on Aging (AAAs)

• Respond to the needs of Americans 60 and older in every community in the U.S.

Title VI Grants for Indian Tribal Organizations

 Provide nutrition, supportive and caregiver services to older American Indians, Alaska Natives and Native Hawaiians

Safe, Stable Housing

AAA/Title VI services and supports for individuals in homes and the community enable them to:

- Live with dignity, health and independence
- Opportunities for full community participation

AAAs Serve a Broad Range of Consumers

78% Serve individuals younger than 60 who have a disability, impairment or chronic illness.





AAA Services for Veterans

- 39% of AAAs provide services to veterans under the age of 60
- Of AAAs who provide home repair and modification services, 48% specifically target veterans



AAAs Enhance Options for Affordable, Accessible Housing with Access to Services




61% provide home modifications and repair services

Goal:

Enable veterans (with disabilities or older) who have frequent health appointments to remain in their homes

Strategy: Transportation assistance tailored to individuals' needs

- Door-to-door
- Also, door-through-door
- Assistance from an aide
- Trained volunteers help stretch the funding
- Priority are individuals who have no or weak support systems

Bear River Area Agency on Aging and Veterans Health Administration

Goal: Improve access to VA benefits and programs

Strategy: Train a team "specialist" in each AAA in Utah to connect veterans to available resources

- Developed a train-the-trainer program and resource guide so specialists can:
 - Inform about VA resources available
 - Assess eligibility
 - Assist with applications
- Engaged community partners

Area Agency on Aging-Region One in Phoenix Justa Center (a nonprofit) & Salvation Army

- Goal: Provide daytime shelter for older adults experiencing homelessness and help transition to more permanent housing
- Strategy: All-day indoor shelter providing meals and optional services between 7 am 7 pm
 - Located 5 blocks from overnight shelter and meets ADA requirements
 - Wellness checks
 - Assistance with benefits, legal services and more
 - Laundry facilities






A Housing and Services Resource Center for Cross-Sector Partnerships

There are an estimated one million veterans who identify as Lesbian, Gay, Bisexual, or Transgender (LGBT).




- In addition, more than 36,000 LGBT service members currently on active duty
- likely up to 87,000 LGBT service members in the National Guard and Reserves





Mission

Volunteers of America of Florida engages Floridians in need to create positive life changes through compassionate support services.

Services for Veterans

- Florida is the most veteran-friendly state in the nation, yet there are over 106,000 veterans living below federal poverty levels in Florida. Far too many struggle to overcome barriers that stand between them and a stable, secure life.
- Volunteers of America of Florida helps veterans and their families find decent, safe and affordable housing and the vital support services they need to stabilize.
- We make sure veterans connect to the benefits they are entitled to, and we make use of the strong bonds forged between veterans by incorporating mentoring and peer-to-peer support.
- We also provide employment services that include assessment, training and placement. Help is available with everything from resume prep to job interviewing, clothing and transportation. Finding work is an important part of building back confidence and pride and sustaining independence.
- We're committed to ending homelessness for the men and women of our region who served their county and to helping all our veterans come "all the way home."

Housing for Veterans

- Volunteers of America of Florida is recognized as the largest provider of supportive housing for veterans in Florida experiencing homelessness, serving 13 communities from Pensacola to Key West. We offer male and female veterans with special needs and their families safe, clean and affordable housing and the vital support needed to survive.
- Our programs serve veterans experiencing or at-risk of homelessness, frail and elderly veterans, and veterans with emotional, mental and substance abuse issues. Comprehensive support services include outreach and assessment, emergency services and case management.
- Transitional housing programs include residential therapeutic treatment for veterans recovering from substance use disorders. Training and employment programs work to place veterans in jobs. The programs ensure that veterans receive the employment and training services they need to get good jobs. The programs offer job counseling, resume preparation, job placement, on -the-job training, career counseling and follow-up employment support, life skills, and money management mentoring. Other housing programs and special need services also serve frail elderly veterans and veterans with mental illness.





SERVICES

Supportive Services for Veterans Families (SSVF)

These programs provide temporary & supportive services for low or no-income Veterans and Veteran families to promote housing stability through assistance and support services to homeless veterans or those at risk of homelessness.

Veterans Case Management

Provides supportive services to Veterans living in permanent housing to assist with strengthening their independent living skills and long-term housing goals. Training, Education, and Employment Program (TEE)

Provides employment and vocational stability to Veterans and people with disabilities. Homeless Veterans Reintegration Program (HVRP), Division of Vocational Rehabilitation, and Ticket to Work programs support individuals as they strive to participate in the workplace and experience the pride of meaningful work.





MORAL INJURY

What is Moral Injury?

Moral injury is the suffering people experience when we are in high stakes situations, things go wrong, and harm results that challenges our deepest moral codes and ability to trust in others or ourselves. The harm may be something we did, something we witnessed, or something that was done to us. It results in moral emotions such as shame, guilt, self-condemnation, outrage, and sorrow.

What is Resilience Strength Time?

VOA | ReST is a free, confidential, group process that supports emotional resilience in people struggling with isolation, fatigue, frust ration, anxiety, and a sense of inadequacy or failure.

Sessions of up to ten participants are scheduled nearly every day, for an hour. People may attend alone or with others they trust. Peer facilitators guide the conversations, and as participants share difficult experiences and listen to each other, they feel understood, empathize with others, and recover a sense of commitment and gratitude for their relationships and work.
